## I. Subject Property

As described in detail in Tulalip Tribes Police Department Incident Report #23-4156, which is on file with the Tulalip Tribal Court under this cause number, on or about the 30th day of December, 2023, Tulalip Tribes Police Department (TTPD) seized a CN Romarm AK-47, serial no. 65790-04 from Sean Covey in the vicinity of 10200 27th Avenue NE, Tulalip, WA 98271 in connection with narcotic trafficking on the Tulalip Reservation.

## II. AUTHORITY

Because the Subject Firearm was possessed during the commission of a crime and further possessed to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance in violation of TTC 3.55, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(9).
