The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. Subject Property

As described in detail in Tulalip Tribes Police Department Incident Report #24-2218, which is on file with the Tulalip Tribal Court under this cause number, on or about the 12th day of August, 2024, Tulalip Tribes Police Department (TTPD) seized a Ghost Gun Rifle AR 15 no serial no., Caliber 5.56 Diamond Back rifle, Palmetto State Armory Upper 556 no serial no., Remington 1100 shotgun, Glock 4th gen 10mm, Ruger MK3 .22 caliber, and Smith & Wesson 40 cal. pistol from Fredrick Puckett in the vicinity of 828 Marine Drive NE, Marysville, WA 98271 in connection with using, intended to be used, or possessed to facilitate the transportation, sale, receipt, possession, or concealment of narcotic trafficking on the Tulalip Reservation.

1	Because the Subject Fircarms was possessed during the commission of a crime and		
2	further possessed to facilitate the transportation, sale, receipt, possession, or concealment of a		
3	controlled substance in violation of TTC 3.55, it is subject to forfeiture pursuant to Tulalip		
4	Tribal Code 2.60.020§(9).		
5	III. Claimants		
6	Fredrick Puckett, Claimant, is a person who the Tribes knows or has reason to believe has		
7	or may asset a claim to the subject property. Fredrick Puckett is believed to be housed at the		
	Snohomish County Jail at 3025 Oakes Avenue, Everett, Washington 98201 (jail registry).
