COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. Subject Property

As described in detail in Tulalip Tribes Police Department Incident Report #24-2259, which is on file with the Tulalip Tribal Court under this cause number, on or about the 16th day of August, 2024, Tulalip Tribes Police Department (TTPD) seized a Ruger LCR .38 caliber, serial no. 541-87464 from Austin Kalista in the vicinity of 10600 Quil Ceda Blvd., Tulalip, WA 98271 as a prohibited weapon that was unlawfully carried by Mr. Kalista in the glove compartment of a vehicle on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Firearm was possessed during the commission of a crime as defined by Tulalip Tribal law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(9).
