The Tulalip Tribes Office of Reservation Attorney gives notice that the property listed below was seized for forfeiture for violation of Tribal Law. You must serve a copy of your answer on the Tribal Prosecutor. You may request a copy of the summons, petition, and evidence in your case from the Tribal Prosecutor.

YOU ARE HEREBY NOTIFIED that the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, has filed a petition with the Court that seeks to have forfeited, to the benefit of the Tribes, certain property that you allegedly own, claim, or have an interest.

Pursuant to Chapter 2.60.070§(4)(a), of the Tulalip Tribes Code of Law, you have thirty (30) days after you have been served the petition and this summons to file with the Court a response to the allegations described in the petition. No extension of the time for filing the response may be granted. Failure to respond within 30 days may bar you from presenting evidence at any later evidentiary hearing regarding the seized property. Further, if no response is filed within 30 days after service of the petition and summons, the Court, upon motion of the Tribes, shall order the property forfeited to the Tribes.

Chapter 2.60.070§(4)(b) governs responses to forfeiture petitions. The Clerk's Office does not provide legal advice. COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #21-0308, which is on file with the Tulalip Tribal Court under this cause number, on or about the 5th day of February, 2021, Tulalip Tribal Police (TPD) seized a 1994 Honda Accord & VIN # JHMCD5534RC016679 from Michael Bond (driver) in the vicinity of 9810 Quil Ceda Blvd., Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).

III. CLAIMANTS

Michael Bond, driver, from whom the subject property was seized and the registered/legal owner of the vehicle, Jeffrey Moore, are the only people who the Tribes knows or has reason to believe has or may asset a claim to the subject property. Michael Bond is believed to reside at 17532 Smokey Point Blvd., Arlington, Washington 98223 (Police Report). Jeffrey Moore is believed to reside at 3922 175th Place NE, Arlington, Washington 98223 (Police Report).

IV. CONCLUSION

Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons to have Michael Bond and Jeffrey Moore answer the allegations of this Petition, and, ultimately, for the Court to order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
