I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #21-2410, which is on file with the Tulalip Tribal Court under this cause number, on or about the 6th day of September, 2021, Tulalip Tribal Police (TPD) seized a \$376 from Lucy Patrick in the vicinity of 15 southbound and 88th Street, Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

II. **AUTHORITY**

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).

2	Lucy Patrick, from whom the subject property was seized, is the only person who the
3	Tribes knows or has reason to believe has or may assert a claim to the subject property. Lucy
4	Patrick is believed to be residing at 7945 Delridge Way, Seattle, Washington 98106 (Police

7	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
8	to have Lucy Patrick answer the allegations of this Petition, and, ultimately, for the Court to
9	order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
