I. Subject Property

As described in detail in Tulalip Tribes Police Department Incident Report #23-0281, which is on file with the Tulalip Tribal Court under this cause number, on or about the 7th day of March, 2023, Tulalip Tribes Police Department (TTPD) seized a \$64,661 Cash from Rodney Simpson in the vicinity of 9511 State Avenue, Marysville, WA 98270 in connection with narcotics trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).
