COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. Subject Property

As described in detail in Tulalip Tribes Police Department Incident Report #24-1821, which is on file with the Tulalip Tribal Court under this cause number, on or about the 3rd day of July, 2024, Tulalip Tribes Police Department (TTPD) seized a Taurus Armas .38 SPL revolver, serial no. AEC206389 & Glock 9mm, serial no. CADB654 from Brian Garzelli in the vicinity of 8924 Quil Ceda Blvd., Tulalip, WA 98271 in connection with narcotic trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Firearm was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(9).

1	III. Claimants
2	Brian Anton Garzelli, Claimant, is a person who the Tribes knows or has reason to
3	believe has or may asset a claim to the subject property. Brian Anton Garzelli is believed to
4	reside 6910 57th Street NE, Marysville, Washington 98270 (Police Report).
5	IV. CONCLUSION
6	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
6	to have Brian Anton Garzelli answer the allegations of this Petition, and, ultimately, for the
7.	Court to order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
