As described in detail in Tulalip Tribes Police Department Incident Report #24-3052, which is on file with the Tulalip Tribal Court under this cause number, on or about the 25th day of October, 2024, Tulalip Tribes Police Department (TTPD) seized a \$147.00 from Sofia Ledecky in the vicinity of 6323 33rd Avenue NE, Marysville, WA 98271 in connection with narcotic trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).
