I. Subject Property

As described in detail in Tulalip Tribes Police Department Incident Report #24-2421, which is on file with the Tulalip Tribal Court under this cause number, on or about the August 30, 2024, Tulalip Tribes Police Department (TTPD) seized a 2004 MBMW 745I from Dustin Nicholson (driver) and Christina Hallman (legal owner) in the vicinity of 3104 116th Street NE Tulalip, WA 98271 in connection with narcotic trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the
transportation, sale, receipt, possession, or concealment of a controlled substance, listed
chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is
subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).
