COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

I. Subject Property

As described in detail in Tulalip Tribes Police Department Incident Report #24-1932, which is on file with the Tulalip Tribal Court under this cause number, on or about the 12th day of July, 2024, Tulalip Tribes Police Department (TTPD) seized a \$876 from Ted Cruver in the vicinity of 6221 31st Avenue NE, Tulalip, WA 98271 in connection with narcotic trafficking on the Tulalip Reservation.

II. AUTHORITY

Because the Subject Money was furnished or intended to be furnished by any person in exchange for a controlled substance or listed chemical in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(7).

1	III. Claimants
2	Ted Stewart Cruver, Claimant, is a person who the Tribes knows or has reason to
3	believe has or may assert a claim to the subject property. Ted Stewart Cruver is believed to
4	reside 702 West Casino Road, Everett, Washington 98207 (Police Report).
5	IV. CONCLUSION Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
6	to have Ted Stewart Cruver answer the allegations of this Petition, and, ultimately, for the
7	Court to order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
