## PETITION FOR FORFEITURE OF SEIZED PROPERTY

COMES NOW the Tulalip Tribes, Plaintiff, by and through its prosecuting authority, to petition the Court to institute proceedings for the forfeiture of the property described in section I, below. The Court has subject matter jurisdiction over these proceedings, and this Petition is made pursuant to, Chapter 2.60 of the Tulalip Tribes Code of Law.

## I. SUBJECT PROPERTY

As described in detail in Tulalip Police Incident Report #21-0783, which is on file with the Tulalip Tribal Court under this cause number, on or about the 30<sup>th</sup> day of March, 2021, Tulalip Tribal Police (TPD) seized a 2014 Land Rover Range Rover & VIN # SALWR2F0EA736574 from David Barbin (driver) and Reliable Credit (legal owner) in the vicinity of 10200 Quil Ceda Blvd., Tulalip, Washington in connection with narcotics trafficking on the Tulalip Reservation.

## II. AUTHORITY

Because the Subject Vehicle was used or was intended to be used to facilitate the transportation, sale, receipt, possession, or concealment of a controlled substance, listed chemical, or proceeds from the sale of a controlled substance in violation of Tulalip Law, it is subject to forfeiture pursuant to Tulalip Tribal Code 2.60.020§(5).

1	III. CLAIMANTS
2	David Barbin, driver, from whom the subject property was seized and the legal owner of
3	the vehicle, Reliable Credit, are the only people who the Tribes knows or has reason to believe
4	has or may asset a claim to the subject property. David Barbin is believed to reside at 10912
5	22 <sup>nd</sup> Drive SE, Everett, Washington 98207 (Police Report). Reliable Credit has a mailing
6	address of 5031 168th Street SW, Lynnwood, Washington 98037 (Police Report).
7	IV. CONCLUSION
8	Based upon the foregoing, the Tribes requests the Clerk of the Court issue a Summons
9	to have David Barbin and Reliable Credit answer the allegations of this Petition, and, ultimately,
0	for the Court to order that the Subject Property be forfeited for the benefit of the Tulalip Tribes.
